DISCUSSION: Ken Evans began by explaining the importance of establishing a schedule. The schedule for the year is set until the end of 2019. The goal of each date was supposed to be every 3 months, consistent with the end of each quarter. Those dates are identified and calendared and an effort to keep locations consistent will be attempted but may be flexible given scheduling conflicts. Receive a Community Benefits Plan Progress Update and Have a Discussion Regarding the Format, Content and Timing of Quarterly Community Benefits Plan Reports to be Provided by LV Stadium Events Company, LLC Pursuant to Section 2.6 of the Community Benefits Plan (For Possible Action)

DISCUSSION: Don Webb gave an update in regard to information that was not in the report presented due to the nature of reporting and the lag time between when numbers are recorded. The current SBE participation is at 19%. With close to 850 million dollars' worth of contracted work, 160 millions has been to SBE firms. There are 66 different companies and firms that are part of that number, and nearly half have multiple contracts. There are also 14 women business enterprise represented and in total for the whole project, 72% of the all work is with Nevada based firms. There is a chance this number may drop, based on the nature of working transitioning from concrete/structural aspects to more steel erection. The number based on other projects and trends will pick back up when interior finished really picks up. Overall, all project trends are in a positive position. The one area for improvements could be for veteran employment. Mortenson/McCarthy has specific programs that can assist with this and the hope is that veteran employment can increase in the future.
