- 1. Call to Order, Roll Call and Establish Quorum
  - Meeting is called to order at 4:00pm by Chairman Lawrence Weekly
  - All board members are present with the exception of Rose Davis.
  - A quorum was therefore established
- 2. Public Comment
  - No public comment was provided at this time
- 3. Approval of Agenda with the Inclusion of Any Emergency Items and Deletion of Any Items (for possible action)
  - Mr. Christopher Sotiopulos moved to approve and it was seconded by Mr. Peter Guzman
  - All committee members voted in favor and the agenda was approved
- 4. Approval of Minutes from May 3, 2022 Meeting of the Las Vegas Stadium Community Benefits Plan Oversight Committee (For possible action)
  - Mr. Peter Guzman moved to approve and it was seconded by Ms. Monica Ford
  - Chairman Lawrence Weekly abstained from the vote as he was not on the committee for the forementioned meeting
  - All committee members voted in favor and the minutes were approved
- 5. Chairman and Committee Member Comments
  - Chairman Lawrence Weekly thanked the Clark County Commission for selecting him to serve
  - Chairman Lawrence Weekly recalled SB1 and the agree set forth and followed by thanking everyone for achieving the goals that were set
  - Mr. Peter Guzman welcomed Chairman Lawrence Weekly to the committee and thanked him for his ongoing service
  - Mr. Christopher Sotiropulos acknowledged Ken Evan's past work on the committee
  - Ms. Monica Ford noted that it is great to see impactful programs first hand when visiting Allegiant Stadium

- Chairman Lawrence Weekly acknowledged Vice President of Finance of the Las Vegas Convention and Visitors Authority Ed Finger for his support
- 6. Receive a Community Benefits Plan Progress Update and Discussion with LV Stadium Events Company, LLC and/or Representatives of LV Stadium Events Company, LLC Pursuant to Section 2.6 of the Community Benefits Plan the During Operations Phase for Allegiant Stadium. (For possible action)
  - Ms. Piper Overstreet-White (SVP of Government & Community Relations for the Las Vegas Raiders) in conjunction with Ms. Brandon Chambers (Director of Community Impact for ASM Global) and Ms. Magaly Davalos (Nonprofit Organization and Community Relations Manager for Silver and Black Hospitality) provided an update on the Community Benefits Plan as of September 27, 2023
  - A presentation was delivered to the committee as well as a written report
  - Topics included event staff diversity, employment outreach programs, business diversity, community engagement and career development
  - Chairman Lawrence Weekly inquired what the "signature programs" are to which Ms. Brandon Chambers and Ms. Magaly Davalos noted the Raiders Den, Gridiron Pitch, the partnership with Three Square Food Bank as well as the nonprofit program at Allegiant Stadium
- 7. Discussion Regarding Future Benefits Oversight Committee Meetings, Scheduling, and Expectations for Reports and Submissions. (For possible action)
  - Chairman Lawrence Weekly turned to Applied Analysis and Mr. Brian Gordon for insight
  - Mr. Brian Gordon suggested getting into a quarterly schedule for meetings based around regular reporting documents
  - Mr. Christopher Sotiropulos recalled meeting quarterly in January, April, July and October on the last Thursday of the month at 1:00pm to which other committee members agreed would be a good schedule moving forward
  - Chairman Lawrence Weekly called upon Mr. Ed Finger who elaborated on the new agreement between the Las Vegas Stadium Authority Board and the Las Vegas Convention and Visitors Authority to serve as staff in place of Applied Analysis
  - Mr. Ed Finger noted that the pace of the Las Vegas Stadium Authority Board meetings will be driven by the formative documents for the baseball stadium project
  - Mr. Ed Finger echoed it would be a good idea for the committee to meet quarterly or when needed going forward
  - Mr. Brian Gordon noted that there is a written report provided which summarizes the Community Benefits Plan updates and that this is the template to use moving forward to provide updates to the Las Vegas Stadium Authority

- Patricia Yin (Owner of Clean and Green Landscape) provided public comment in support of Allegiant Stadium's work on reducing the usage of water
- Tiffany Nguyn (Owner/Partner of Dirt Dog) provided public comment in support of the Community Benefits Plan that has allowed her small business to be able to operate in the stadium

#### PURPOSE AND BACKGROUND

Senate Bill 1 of the 30th Special Session of the Nevada Legislature (SB1), the Southern Nevada Tourism Improvement Act (Act), was signed into law in October 2016. The Act provided for the financing and development of Allegiant Stadium.

Section 29.5 of SB1 required the developer partner (DevCo) of the Las Vegas Raiders and StadCo to develop a Community Benefits Plan to ensure the greatest possible participation by all segments of the local community in the economic opportunities available in connection with the design, construction and operation of the National Football League stadium project developed by the developer partner and operated by StadCo.

SB1 established the Stadium Community Oversight Committee (Committee) to carry out the Plan and to enforce the Plan's provisions. Pursuant to the Plan, the Committee is charged with monitoring, oversight, and accountability in connection with the performance of the Plan. The Plan requires public reporting identifying StadCo's operational compliance with the Plan.
